



Terms of Use

The following terms and conditions govern all use of the Eyonice.com website and all content, systems, services and products available at or through the website (taken together, the Website). The Website is owned and operated by Eyonice Systems Inc. ("Eyonice"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Eyonice's Privacy Policy) and procedures that may be published from time to time on this Site by Eyonice Systems Inc. (collectively, the "Agreement").

Please read this Agreement carefully before accessing or using the Website. By accessing or using any part of the web site, you agree to become bound by the terms and conditions of this agreement. You must agree to all terms and conditions of this agreement to access the Website or use any services. If these terms and conditions are considered an offer by Eyonice, acceptance is expressly limited to these terms. The Website is only available to individuals who are at least 13 years old.

The prevailing party in any action or proceeding to enforce this Agreement shall be entitled to costs and attorneys' fees. If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms and conditions; Eyonic may assign its rights under this Agreement without condition. This Agreement will be binding upon and will inure to the benefit of the parties, their successors and permitted assigns.
